# *Andrew Thomas Golomb*

The University High School Alumni Association honors Andrew Thomas Golomb, class of 1997, as a 2017 Hall of Fame Alumni Award Recipient for his contributions to his profession and civic service.

Golomb graduated from University High School in 1997, where he earned the following awards and distinctions: National Honor Society Member, Mu Alpha Theta, Debate – National Forensics League, CAPTAINS, Key Club, Student Senate, 3 Sport Varsity Letter Winner and Team Captain, Corn Belt Electric Scholarship Winner, and Class of 1997 Scholarship Winner.

After high school, Golomb attended Butler University in Indianapolis, IN, where he achieved a 3.6 GPA with Honors and earned a Bachelor of Science Degree in Finance in 2001. He later went on to earn a Master of Business Administration from the prestigious University of Chicago Booth School of Business, where he was named to the Dean's List (Top 15% of Class).

Golomb prides himself on hard work and dedication, and has accomplished a great deal throughout his young career. He is currently a Director for Bank of America Merrill Lynch in the Global Principal Investment Area. He was quickly promoted two times to his current position in a little over five years.

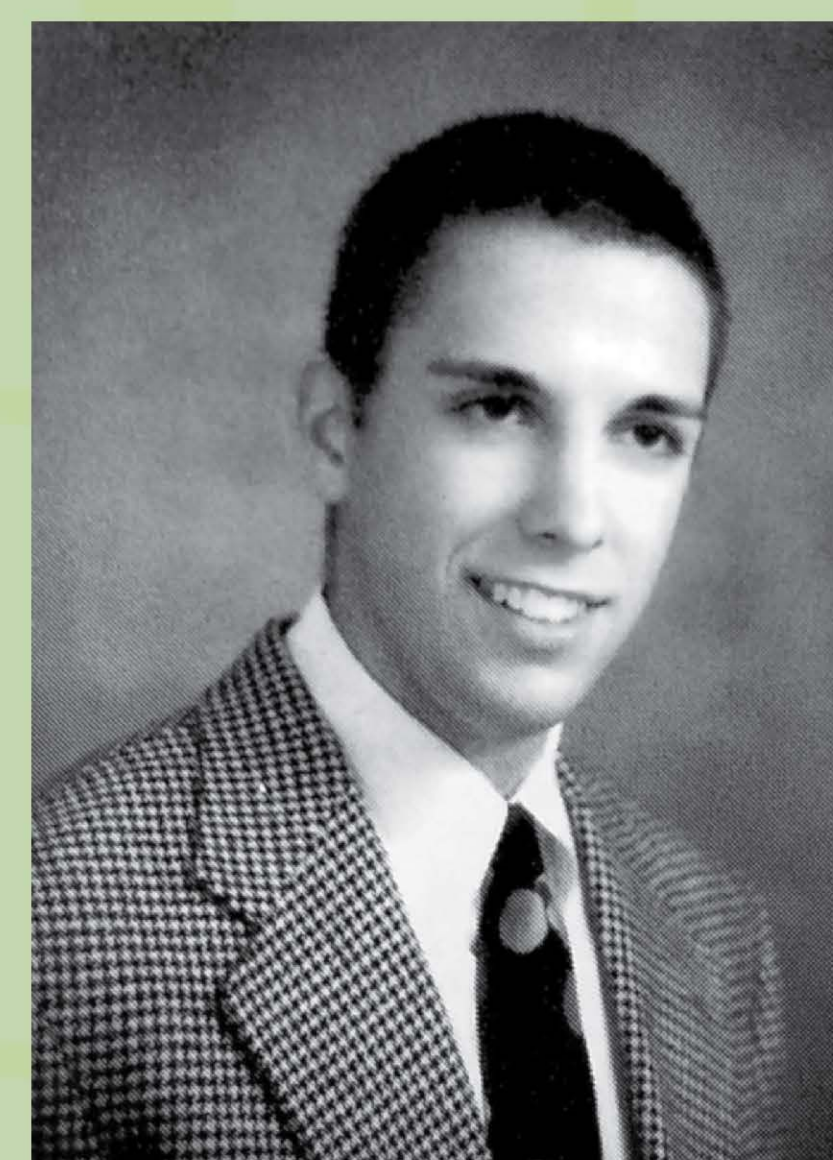
With Bank of America Merrill Lynch, Golomb serves as a private equity investment officer, managing, structuring, and valuing a \$220 million portfolio of private and public equity investments using proprietary capital. He has been directly responsible for managing over 200 investments, recovering over \$350M in capital from the sale of over 150 investments, with gains of more than \$200M.

Golomb also serves on 15 corporate boards including BIDS, Curve Global, TIM Group, Porter Group, Finacity, Business Lenders, and Resort Funding, where he reviews budgets, operations, structuring incentive plans, and M&A opportunities.

Prior to his current job, Golomb also worked at Morningstar, Inc. and Merrill Lynch Business Financial Services. Some of his top accolades with these organizations included: ranked 1st out of 95 analysts for highest returns in 2006 (annualized returns in excess of S&P500), profiled twice in The Wall Street Transcript, Top 2% out of 200 credit managers to reach their liability management goal in 2003, and Top 3% out of 300 employees to be nominated for the MLBFS Principals Award in 2004.

In addition to his career, Golomb has also demonstrated great leadership and service in community activities. He has dedicated a significant amount of time by serving as the Chair of the United Way of the Central Carolinas – United Way Young Leaders organization. Golomb also was the founder of the Merrill Lynch/Joseph Stockton Chicago Public School Mentoring Program. He specifically organized the involvement of 75 Merrill Lynch employees from four separate Chicago offices to mentor 3rd graders at an inner-city Chicago public school. Golomb's efforts led to Merrill Lynch being recognized as an official partner of the Chicago Public School System.

Golomb is currently married to his wife, Nicole (Bills) and they have a son, Oliver. His parents, Larry and Donna, are also instrumental in their support. His sister and brother-in-law, Janeen and Barrett Moore, also graduated from U-High. In his spare time, Golomb is also a Marathoner (including Boston) and enjoys cycling, hunting, and SCUBA diving.
